2. Literature Review

Role according to sociologists, such as Raph Linton, namely "the dynamic aspect of status" a person carries out a role when he carries out the rights and obligations which constitute a status, while a status is "a collection of rights and duties" a collection of rights and obligations. (David Berry 1998,p.135). The role according to the definition of experts states that the role is a dynamic aspect of position or status. Someone carrying out rights and obligations means having carried out a role. The role shows more on the function of self-adjustment, and as a process. Family is a place where individuals grow, develop and learn about values that can shape their personality in the future. The learning process continues as long as the individual lives. Ahmadi stated that, the family is a very important forum between individuals and groups, and is the first social group in which children become members. Of course, the family is also the first place to socialize children's lives. (Irma Rostiana, 2019, p.1).

According to Friedman, a family is two or more individuals who are joined by blood relations, marital relations or appointment and they live in one household, interact with each other and in their respective roles create and maintain culture. According to the Big Indonesian Dictionary (KBBI) family support is an encouragement or psychological assistance provided by the family to their children (Big Indonesian Dictionary, 2003). Family support is an effort given by the family to children or other people to encourage people to do something they want to achieve (Sarwono, 2003).

The definition of educating, according to the Big Indonesian Dictionary (KBBI), the word educate means nurturing and giving training (teachings, derivatives, leadership) about morals and intelligence. According to KBBI, education is the process of changing the attitude and behavior of a person or group of people in an effort to mature humans through teaching and training. - 1) Responsibility for education and fostering faith. The purpose of this responsibility is to bind the child to the basics of faith, Islam, since the child begins to understand and be able to understand something. The basics of faith in this sense are everything that has been established by way of khabar correctly in the form of the essence of faith and occult matters. pass on those words to your children, as well as Ya'qub. Ibrahim said 'O my children, indeed Allah has chosen this religion for you, so do not die except in embracing Islam''.
- 2) Responsibility for education and moral development This responsibility means education and coaching regarding the moral foundations and virtues of temperament, the character that children must have since they are young, until they become adults or mulattoes. In one of the Hadiths narrated by Ibn Abbas, Rasulullah saw. said, "Approach your children and educate them and develop their morals." Morals are the implementation of faith in all forms of behavior. Education and moral development of children in the family is carried out by example and example from parents. Examples are found in the behavior and manners of parents in the relationship and association between mothers and fathers, the treatment of parents towards their children, and the treatment of parents towards other people in the family and community environment.
- 3) Responsibility for maintaining children's health. The purpose of this responsibility is related to the development, physical development of children so that children become healthy, intelligent, tough and brave children. Therefore, parents are obliged to provide food with halal and good food (halalan thayyiba), maintain physical health, accustom children to eating and drinking with permitted and nutritious food and drink.
- 4) The responsibility for education and intellectual development, this responsibility means the formation and development of children's thinking with everything that is useful as well as awareness of thinking and culture. This intellectual responsibility is centered on three things, namely: the obligation to teach, awareness of thinking and healthy thinking.
- 5) Personality and social responsibility of children. This responsibility means that it is the obligation of parents to instill children from childhood so that they are accustomed to carrying out social manners and relationships with each other. When a child is still pure, adults have great concern for him, so the social spirit and attention being true to others is what will grow strong in his soul.

The role of the family environment in child development can be provided through internal and external supervision. Creating the best generation of children can be done through expertise and patience in providing an education system. This is intended to be aware of the integrity of attitudes and behavior in the development of children. Both from the aspect of attitude, behavior and social growth of children who always blend in with the surrounding environment.

The role of the family environment is integrated with the role of the school and community. Many parents are busy only entrusting the development of their children to schools (educators/teachers) and employing the community (helpers) to take care of their children without controlling the development of their children, so that children's attitudes and personalities vary according to the situations and conditions they get. What should be in the context of Islam is that every parent can be an adaptive soul to their child's development, prepare good companion parents when parents carry out work outside the home, so that their children can grow better and prepare their children by choosing a safe and comfortable place for development. whole child through a process of value transfer, communication and creativity potential of each of these children. In line with this is Achmadi's explanation in the Islamic context that: Education is an investment in the future to prepare quality human resources. Experts generally view that education is a process of developing individual potential, cultural inheritance, and interaction between individual potential and their environment towards a full life. (Achmadi, 2005, p.28-29).

Character education will run effectively and intact if it involves three institutions, namely family, school and community. Character education will not go well if it ignores one of the institutions, especially the family. Informal education in the family has an important role in the process of forming one's character. This is because the family is the environment for children to

grow and develop from an early age until they become adults. Through education in the family the character of a child is formed. (Amirulloh Syarbini, 2014, p.3).

Children's age is a sensitive period to receive various kinds of stimuli from the environment to support physical and spiritual development which also determines the success of students following their education in the future. According to Soemiarti Padmonodewo, the quality of a child's early childhood (early childhood), including the pre-school period, is a reflection of the quality of the nation in the future. (Soemiarti Padmonodewo, 2005, p.41)

Parents as educators first and foremost have a direct interest in efforts to maintain and foster children's development from phase to phase, especially when children are in their early years of development and growth. In addition, parents also have an obligation to raise children on the basis of understanding and the basics of Islamic faith and teaching education since their infancy. Parents should have a strategy in their role of implementing parenting and education patterns more precisely.

In this case the concept of parents is not only parents who give birth to children, but also parents who nurture, protect and give love to children. In detail it can be described the importance of the role of parents for children's education, namely "parents are the first and main teachers, the main protectors of children, a source of life for children, basically the key to education in the household lies in spiritual education, in the sense of heart (religious) education, because religious education plays a very large role in shaping one's personality and outlook on life, there are two directions regarding the use of religious education in the household, namely:

- 1) Instilling values in the sense of a view of life that will color later development of body and mind.
- 2) Planting attitudes that will later become the basis for respecting teachers and knowledge in schools. (Ahmad Tafsir, 2014, p.157).
