Because by maintaining politeness in language so that interaction is maintained as well communication goes well, language is used every day therefore someone can judge us from the conversation, 2) politeness

It's really not good if it keeps happening continuously, with thereby matter That relate with influence pattern foster parent (Fahrudin, 2018).

Parenting styles can have a big effect on a child's growth. Thus every children will have different characteristics because of differences in parenting . In line With that opinion, Putri said that this is a different parenting style that shows the difference characteristic independence child besides That can form character child through activities in life everyday like manners, good manners, and other characteristics (Putri & Lestari, 2021) . Whereas according to Djuwita teacher has responsibility the big one to morals and morals student To use guiding and giving examples to students to behave correctly and not letting participants educate him if there are things that damage his morals (Djuwita, 2017). Due to the age of the participants educate madrasah tsanawiyah this is a child currently in time development Where participant educate feel sensitive to the surrounding environment.

This is in line with Amaruddin's thinking that moral values in children must be taught continuously to the child so that the child is able to behave well so that the child do not do things that are not related to the applicable norms (Amaruddin, 2020). Positive behavior that must be taught to children from madrasah tsanawiyah such as how to treat other people, method speak, as well as method socialize. By Because That education at the madrasa very influence attitude children in everyday life . In the activities in the madrasa participants educate can show good manners such as respecting the teacher, not speaking harshly, not fighting each other between friends, and each other Help help without see race, ethnic group And religion.

From previous research conducted by Ujiningsih and Antoro (Ujiningsih & Antoro, 2010) related attitude culture good manners get results that implementation process attitude culture polite polite only can held through habituation Which done Good in environment House as well as school. This is in line with research conducted by Rohendi (Rohendi, 2011) that habituation of this polite attitude must start early, if not get used to so will difficult For change character And attitude somebody.

Supriyadi (Supriyadi, 2019) argues that as a teacher, he must be able to set a good example to others participant teach them so they can see what the teacher is doing. At the time of learning even the teacher must can make learning fun so that children don't always feel bored. Whereas Norbayah

(Norbayah, 2017) states that madrasas can apply 5S habits, namely polite, polite, smile, greet, and greeting. This 5S habit must be familiarized by the teacher to the participants teach to have favor character And system manners Which Good. Besides That, culture 5S This there is mark Which Good also likevalue fellow, each other honor as well as love.

4.2. Discussion

Nurjannah said that in realize education character, madrasa can do many things. The concept of character is not just one point in the curriculum or study program, rather it must be detailed and go beyond that by executing and implementing it (Nurjannah, 2018). Education for this character must be made into a rule or order in the application of values, so that it can work good at madrasa h. This can be realized with a real invitation or an example shown by energy education And Also educator in madrasa in activity daily in environment madrasa. Even with prohibitions and orders, it will make children feel insecure and tend to be afraid with the surrounding environment. As for the things that parents must pay attention to, namely, parents must know what they want done by the child and give freedom, as previously explained if the child has trend For follow behavior person his parents. Person old Also must know that child must treated differently when he was at home from when he was at the madrasah. And regarding these manners must get used to by person old since age early.
